ARCH 475: PROFESSIONAL ARCHITECTURAL PRACTICE II

Course Description: This course is a forum for examination of the structure and practices of the

profession of architecture. The relationship between architecture, the arts, society and the role of architecture as a business are explored. The formal and informal relationships between architects and its key stakeholders; clients, government officials, and consultants are studied. The basic principles of office management and business practices for the small and large architectural firm are introduced. Issues related to the architect's legal responsibilities, the protection of the public welfare as well as professional ethics and liability are discussed.

Course Outline: Architecture spans the worlds of business, art, science and engineering while residing within complex social, economic and environmental contexts. Because of the distinctive station architecture maintains relative to other professions, students must be equipped with an understanding of the unique multifaceted field of architectural practice. The objectives of the course are to expose students to the breadth of the architectural profession while preparing students to recognize the responsibilities of leadership and ethical decision-making which design professionals are required to uphold. Specific topics covered in this course include, but are not limited to:

- An Overview of the Profession: Who Is an architect and where do they come from?
- Clients and Firms: Who are clients and owners and what type of firm are out there serving this population?
- Project Delivery: How are architectural projects conceived and put into place?
- Agreement and Conditions: What are the roles and responsibilities of those involved in design and construction projects?
- Regulations: A review of critical codes and ordinances impacting practice that address life safety and welfare of the public.
- Licensing: How do architects gain the right to practice?
- Liability and Risk: What are the risks associated with designing buildings and what standards must architects meet in the execution of their work?
- Contract Administration and Project Management: A discussion of what do architects do during a construction project along with an investigation into the qualities of leadership that architects demonstrate in practice.
- Issues In the Profession, Ethics, and the Future: Because architects engage with individuals, communities and the general public at large, they come face-to-face with all manners of social, political and economic matters. How do architects respond and how should they?

<u>Delivery</u>: The course is offered as a lecture-based class delivered face-to-face. Using NJIT mandated Canvas platform, course information, readings, assignments, lecture notes, and presentations will be posted regularly. Canvas discussion forums may be used to facilitate class conversations and dialogue.

PC.8 Social Equity & Inclusion - How the program furthers and deepens students' understanding of diverse cultural and social contexts and helps them translate that understanding into built environments that equitably support and include people of different backgrounds, resources, and abilities.

SC.2 Professional Practice - How the program ensures that students understand professional ethics, the regulatory requirements, the fundamental business processes relevant to architecture practice in the United States, and the forces influencing change in these subjects.

SC.3 Regulatory Context - How the program ensures that students understand the fundamental principles of life safety, land use, and current laws and regulations that apply to buildings and sites in the United States, and the evaluative process architects use to comply with those laws and regulations as part of a project.

COURSE STRUCTURE:

Students are **required** to review and study course material prior to the scheduled meeting times **and participate** in class discussion sessions lead by the instructor and classmates.

Quizzes, Exams and Assignments: Quizzes and exams are administered using the Canvas Responder LockDown Browser tool. Students are to download the browser and take the sample test in advance of the first test date to make sure everything works properly. Assignments are to be completed individually or by groups when specified. Group assignments shall be uploaded to Canvas by only one group member.

MEANS OF EVALUATION:
