COURSE DESCRIPTION:

This course will present an introduction to the art and tools of music. We will learn how to appreciate music from the fifteenth to the twenty-first centuries, examining how technologies, from musical instruments, through amplification, recording, and computer technology, have changed the way we make, listen to, exchange, and conceive of music from various parts of the world.

One aim of the class will be to get students to listen to and understand kinds of music that they haven't thought much about before, from classical to world to popular to experimental genres. The course will focus on listening and understanding, with the hope that your ears can be opened to new sounds and new possibilities, so you will be able to hear more than you have ever heard before.

It is a recommended prerequisite to all the other music courses at NJIT.
